

2013 Yankee District #7 Hellenic History Tournament

On November 16, 2013, the 5th Annual Hellenic History Tournament took place at St. Barbara's Greek Orthodox Church in Orange, CT. What an exciting event! This is what AHEPA and Hellenism is all about. Our younger generation is showing us the way.

Originally, there were 17 registered teams of 3 students each, but 3 dropped out in the last week, so only 14 teams showed up to compete. Also, 3 additional team members were unable to attend and could not find replacements, so there were 39 contestants. It was a truly regional contest with 10 chapters (Nashua #35, Paramus #54, New Haven #98, Stamford #99, Norwich #110, New Britain DoP #138, Newport #245, New Rochelle #405, Watertown #406 and Wyckoff #453) from 6 states (NJ, NY, CT, RI, MA and NH) and 5 AHEPA Districts (5, 6, 7, 8 and 9) fielding teams. It was a sudden death elimination tournament, with each team competing with another in the 1st round, with the losing teams dropping off until only 2 teams are left in the 4th round.

The tournament depends on many volunteers: Chaperones (members of the students' communities) make sure the students sign up, form teams, study, and show up at the event; the Set up Crew (members of the New Haven chapter) prepares the hall and the classrooms and provides and serves the food; our Technical Support team (Kip Kyprianou) sets

up the computers and projectors in each classroom; Moderators (Nina Barclay has moderated more matches than any other moderator in the 5 year history of the tournament) operate the computerized match guide during each match; Scorekeepers keep a manual tally of as backup in case the computer malfunctions (has not happened yet); the Dispute Resolution Advisor (Greg Stamos) is ready to help resolve disputes among teams; the Photographer (Greg Simones) memorializes the proceedings. And of course, the prize money is provided by the sponsoring chapters. A big heartfelt THANK YOU to all our volunteers!

This year we had the opportunity to engage John Grossomanides, immediate Past Supreme President, and Alex Boutsioulis, Lieutenant Governor, as moderators. Following are some photos taken before and during the matches.

The Feta kai Psomi team, comprised of Nicholas Georgiou, Yiorgos Argyros and Christian DeKnatel, sponsored by the New Rochelle Chapter #405, won the final match and the Tournament. They each received \$1,000 and a Hellenic History Trophy. New Rochelle President, Joe Keane, received the shared chapter Hellenic History Trophy. They get to inscribe it with their chapter's name and number and to keep it for a year until the next tournament. This is the 1st time the Trophy was won by a chapter from another district.

Second prize went to the Newport Team, consisting of Theodore Panoutsopoulos and Nikolaos Spentzos. They each received \$500 and promised to come back for a first prize win next year.

lenic History Tournament).

On October 26, 2013, the Stamford chapter held its annual dinner dance fundraiser for the benefit of the national AHEPA humanitarian relief effort for the people of Greece (which goes directly towards the acquisition and shipment of food and medical supplies) and the Stamford AHEPA Scholarship Fund (which goes mostly to the two Greek Schools of Stamford, Annunciation and Archangels, to neighboring Greek schools, to send local high school juniors to AHEPAcademy, and to sponsor teams competing in the Hel-

The theme of the event was Passing the Torch, a tribute to the father/son (or son-in-law) pairs who are both AHEPAns. The elder AHEPAn of the pair received a "Torch of Hellenism" which he passed on to the younger AHEPAn. The younger honorees from Stamford who attended and received the "torch" plague were Vasilios Diakogeorgiou, Tom Hatzis, Nicholas Kiratsous, John Louizos, Nikiforos Mathews, Chris Nanos, Chris Paul Nanos, George Nanos, Paul and Peter Poulos, Peter Ramoglou, and John Skoparantzos. Other AHEPA chapters were invited to send their father/sons to be honored. John Grossomanides joined us from Norwich, CT #110, Peter Handrinos from Norwalk, CT #387, Alexander Nikas from Norristown, PA #432, and Greg and Paul Stamos from New Haven, CT #98. In addition to Passing the Torches, the chapter acknowledged three individuals: Alexi Nikolopoulos, our scholarship winner for last summer's AHEPAcademy; James W Cocolis for his contributions to the chapter's success as President; and John Grossomanides for his outstanding leadership of national AHEPA and for his support of our chapter.

About 165 people attended the event at Norwalk Inn and were entertained by Grecian Nights. Among them were James W Cocolis, president of the Stamford chapter; Theologos Demetriades, president of the Norwalk chapter; Alex Boutsioulis, Lieutenant Governor, Yankee District #7; Nicholas Nikas, Supreme Governor, Region 4 (New England); Greg Stamos, Supreme Counselor; Andrew Zachariades, Supreme Treasurer; John Grossomanides, immediate Past Supreme President, and Grand Vice President Anna-Helene Grossomanides. The event committee was co-chaired by chapter Vice President John Louizos & Master of Ceremonies Nikiforos Mathews. Other committee members were chapter President James W Cocolis, Dino Kallenekos, Arthur Kiratsous, Brett Kubisek, Nicholas Nikas, Theofilos Nikolis, Paul Poulos, Peter Poulos, John Skoparantzos and chapter Secretary Dimitrios Vasquez.

Preliminary results indicate that we raised \$13,500. We have already given \$6,000 to the AHEPA Charitable Foundation (Greek Relief with Apostoli). We plan to give \$3,000 to Archangels Greek School and \$3,000 to Annunciation Greek School. We'll keep \$1,500 in our chapter's educational and philanthropic fund for future contributions to the Hellenic History Tournament, AHEPAcademy, etc.

Dr. John Grossomanides Testimonial Dinner



"A SALUTE TO A VETERAN' - Ted Lainas

Ted Lainas was born Telemahos Gus Lainas in Brooklyn, New York, April 21, 1924. His childhood was quite typical of that of immigrants' children. He worked hard in school



and in his father's luncheonette. When it came time for high school, he was told that he would become an engineer like a cousin in New Jersey. No one, certainly not Teddy, spent a minute considering what **he** might want to do.

When he was 17, things changed with the attack on Pearl Harbor. His parents wanted to continue his education in college. He, however, wanted to defend his country. He enlisted in the Navy planning to be a pilot. The Navy had other ideas. He was put onto an LST and sent to the Atlantic where he was part of the momentous invasion of Normandy. After Normandy, he was shipped to Okinawa during the occupation. He was awarded the Good Conduct Medal, a Bronze Star, the American Campaign Medal, European-African-Middle Eastern Campaign Medal, the Asiatic-Pacific-Campaign Medal, and the World War II Victory Medal.

After the war, he returned home and did indeed become an engineer, earning a BME degree from the Polytechnic Institute of Brooklyn, NY. While he was in the Navy, his younger brother used to tell his Sunday school teacher, Ramona Harisiades, about his war hero older brother. One summer day at the beach on Coney Island, Ted and Ramona met. They were married April

23, 1950, two days after his twenty-sixth birthday. My father picked that date so that he would not ever forget their anniversary. I was born the following September. Two years later, March 11, 1953, he was initiated into AHEPA.

Ted had a job offer from US Rubber in Mishawaka, Indiana and then moved the family to South Bend in 1954 with a plan to come back to the East. Imagine the culture shock of moving from New York to the Mid-west in the 1950s! In February, 1955, Ted was transferred to Naugatuck, Connecticut in 1956 on the heels of the great flood of 1955. He settled in Waterbury because that was where the church was. Both Ted and Romona became very active in Holy Trinity, my dad serving as president of the Parish council and my mother as a Sunday school teacher. My father also served as the Waterbury AHEPA Chapter 48 president.

Ted had a very successful career with Uniroyal, as US Rubber had become, as a senior research scientist. He was granted two patents and published in several industry journals. He was developing green technology at its nascence as a consultant for rubber and plastic extrusion. His work involved recycling tires for use in all-weather running racks, tennis courts, and automobile brake pads. He taught engineering courses at the University of Connecticut (Waterbury branch) and at the Waterbury State Technical College for many years.

Ted Lainas died June 5, 2010, fittingly, the day before D-Day, at the age of 86.

1. Eligibility

- A. Applicant must be currently attending college or postgraduate school and plans to enroll as a full-time matriculated student in the next academic year.
- B. Applicant must have at least a 2.5 GPA.
- C. The applicant must either be a member or child of a member in good standing of the AHEPA Family organization of District # 7. A member is defined as being in good standing if all financial obligations to their Chapter, District Lodge and National have been paid.
- D. Applicant or family member must have become a member of the AHEPA Family organization prior to April 15, 2013.
- E. Applicant may receive a total of **three** AHEPA District # 7 Scholarships.

2. Filing

- A. All information requested must be submitted for the application to be considered complete. Incomplete applications will, not be officially accepted or considered for a scholarship.
- B. All information submitted will be held in strict confidence, only the scholarship committee will review this information and it will not be returned.
- C. Only information requested will, be considered. Letters of recommendations or testimonials are not required and will not be reviewed.

3. Procedure

- A. This completed application must be typed out or legibly printed.
- B. A **sealed stamped official transcript** of the most recently attended academic institution. This official transcript may be mailed by the academic institution directly to the Scholarship Chairperson or submitted with the other required parts of the application.

YANKEE NEWS' HISTORY SEGMENTS: Volume I - Oral History (Myth) By G.A. Rados, Historian/Hellenic Affairs Chair

Myth #2: Iraklis/Hercules, the most renowned hero and demigod

To begin with, the name is a composite of two words: Ira/Hera + kleos (fame/glory), in other words, it means: for the fame/glory of Hera (Hercules' labors meant to appease and glorify Hera but ended glorifying him instead).

I suppose most of us know that the 'Father' of gods and humans, Zeus (Zefs/Dias) was married to his sister Hera (Ira), both being 'primus ante pares' among the Olympian gods of the Greek pantheon. Zeus was well known for his extramarital affairs (Hera wasn't that innocent either!) which made his wife/sister very jealous. Since Hera could not do anything if and when Zeus had an affair with another goddess, she would direct all her anger and revenge at the mortal women foolish enough to consent to Zeus' advances. Further, she would direct pain and misfortune to that woman's offspring, so it would hurt a sinful mother.

In our case, Alcmene (Alkmini), a mortal woman from Thebes (Thivae) in Boeotia (Viotia) married to the king of Mycenae (Mykinae), accepted Zeus' advances and became pregnant. Hera got so angry, she promised to punish the soon to be born child in any way she could think! Meantime, Alkmini (royalty or not) could not escape some sort of punishment by her own peers and she was sent packing back to her parents at Thebes.

Nothing truly mythic thus far. Even in our days, 'higher-ups' tend to receive a lighter punishment for their sins than 'us common folk'. Additionally, royal house members in those times (the trend lasted well into our era) were considered to be descendants of deities or, at the least, god-appointed rulers representing the deity on Earth. Judgment of their acts was left to the deities only.

Back to our story: Alkmini's newborn was a male named Iraklis, in the hope that Hera would be appeased. The goddess though had nothing but revenge in her mind. While Iraklis was still an infant, Hera reportedly sent two snakes into his crib, to strangle the boy. He, being the son of Zeus, was gifted with extraordinary strength and he strangled the snakes, causing wonder among the mortals! Nice myth eh?! Not necessarily so, if we exclude the obvious exaggerations and religious fantasies.

First, we know that infants are blessed with surprisingly greater strength than their age would suggest, especially in their hands. If Iraklis did really exist and if by being of royal blood had better care than common infants of his time, wouldn't he be of better body condition? The answer is yes. Now if the snakes were two small garden snakes lured by the smell of milk in the infant's crib and got into it, couldn't he be playing with them for a while before his uncontrolled baby strength (accidentally or not) squeezed them to death? Possible? Yes, considering the feat was repeated -and recorded in a newspaper-in Greece during the 1960s! Would a royal

house take the opportunity to self promote its connection with the deities -if such an event took place- to further awe the commoners? You bet it would and the ignorant and superstitious folk would accept it in wonder! As an example, check the amazement our society shows in any silly 'achievement' of the House of Windsor!

So, our hero grew up as a proper royal always does, with plenty of mental and physical exercise becoming a smart and strong man! He got married and had a full sized family for a while. Royalty though has its shortcomings too! Having things coming always his way and plenty of flatterers around him, the stuff got into his head and, during a family argument on who's right, his anger led him to kill his wife and children! Obviously, a royal could not be brought to common justice for punishment -at least not in that era. Regardless of his hideous crime, he was to be judged only by the gods! Probably very remorseful himself, he went to Apollo's (Apollon) shrine and asked how he could be redeemed.

Apollo, also a son of Zeus and knowing well Hera's fits of anger and revenge, ordered Iraklis to forget all about royalty and throne aspirations. Instead, he should go to the service of his cousin and current king of Mycenae, Eurystheus (Evristheas) -the word's meaning is the one who can be seen broadly- as a common man and perform twelve labors. Each labor would be for each of the Olympian gods, as a means of exoneration and forgiveness. Provided he (Iraklis) would achieve these labors, not only would he be forgiven but, as the labors would benefit Evristheas and the common people. Iraklis could count on being declared immortal! Our hero, knowing well that due to his crime he had no chance of pursuing the throne, accepted and went in the service of Evristheas (the lure of becoming immortal on top of being forgiven was not a thing to take lightly, no matter who you are or in what era you live in)! His cousin, the king of Mycenae, was more than glad to have Iraklis do any and all of his 'dirty' works! First, it would keep Iraklis at bay, second, it may result in Iraklis' death (no throne competition), thirdly, achieving all kinds of benefits for the throne -in case of success! All these do not sound too mythic to me! They are rather too human and too pragmatic, applying in all ages' behavior! So, we will examine all labors next, excluding fantasies and exaggerations and leaving only what was/is possible and probable of happening in the story.

The first assignment was to have a maneating lion exterminated from the realm's region of Nemea. Remember now the upbringing of our hero: well educated and trained in both mind and body! Observant, he knew what we all know today about a lion's habits. When a lion has its meal to contention (especially a male one), does not pay attention to any other potential food source, until hunger comes back! We all have seen document-aries showing gazelles

passing unmolested by lions which have recently had their meal and are laying down digesting and even taking a good nap! What did Iraklis do? He made sure the lion had its meal first, observed it being in a half-asleep condition, approached it and stunned it first with a heavy club, then killed it with a sword and skinned it, placing its pelt on him for effect! Reporting back to Evristheas, he left the part of the sword out of the story, for better self-promoting reasons (one would do the same today, given the circumstances)!

While the common people were happy and thankful, Evristheas ordered Iraklis to his second labor (athlos= achievement in Greek). The task was to deal with a stagnant lake Lerni/Lerna. Its waters (Ythor/Ydor in Greek) were causing great ills in the surrounding villages and ignorance combined with fear of death, sparked the peasants' imagination as if there was a monster in their midst, the Lernea Hydra!

The medical abilities of the local 'doctors' and the hygiene kept by the locals was creating worst conditions, to the point that one illness treated would most certainly produce two or more following up! No wonder the popular imagination had perceived the whole affair as a monster with nine heads! Our hero knew better (always remember his upbringing)! He called upon his nephew Iolaus (Iolaos) and the two of them with the method of cutting and cauterization when was needed, got rid of all the 'heads' of that 'Lernea Ydra' thus eliminating the cause of illness and death!

The popularity of Iraklis rose even higher among the thankful peasants and commoners, making Evristheas more anxious. Prompted also by Hera, he ordered Iraklis to perform what could be considered sacrilege, thus bringing the wrath of another deity on the head of our hero! Evristheas asked for the favored stag of the hunter goddess Artemis (Diana) to be brought alive before him! His aim was that the goddess would be so offended that she would kill Iraklis instantly! Here comes the connection/relationship of royalty/ priest-hood and self-appointed, godgiven importance of the 'high-ups' in all eras of human History. One (Evristheas) consults and schemes with one deity (Hera), the other (Iraklis), goes to Artemis for a personal request. The hero explains to the goddess his predicament and she agrees (as sister of Apollo and daughter of Zeus she dislikes Hera too) to let Iraklis take the 'golden' stag to Evristheas unpunished.

You see, kingship and priesthood may be cooperating at times to keep commoners underfoot but they don't always agree and like one-another! Case in point all differences and hate existing to this date between religious sects, religious leadership, ambitions followed by crimes and led by kingpriests or executive 'high moguls' throughout our human History! Why shouldn't Greek cases be among the first orally transmitted (and embellished) from one generation to the next? No reason at all!

A SALUTE TO A VETERAN" Peter Stamos

After the defeat of the German army in the Battle of the Bulge, Peter was shipped with the 8th Army to Czechoslovakia as part of the Army of Occupation. "After the war's end, while still in Czechoslovakia, He was able to visit various parts of the

country, seeing many beautiful areas and castles. This developed his love of travel and in later years he was able to travel extensively throughout many countries in Europe and the near east along with the Western U.S."

Thanks to the G.I. Bill, Peter was able to further his education. He received a B.A. in Education from New Haven's Teacher College (now Southern Connecticut State University), a M.A. degree in Administration from Columbia

Teacher College (now Southern Connecticut State University), a M.A. degree in Administration from Columbia University, a Sixth Year Professional Degree from Fairfield University and has completed all course requirements for a PHD at the University of Connecticut.

"During this time he met his future wife of 53 years, Mary Vartelas, at a Greek dance in Bridgeport. Peter and Mary had 4 children (Gregory, Lisa, Paul and Paris) who gave us 4 lovely grandchildren and 1 great granddaughter. Peter has always believed in serving his church and community.

Constantine "Gus" Hologgitas, 93, of Newport, RI, died Wednesday, April 10, 2013 at home in Newport, RI after several years of chronic illness. He was the husband of Dr. Joanne (Vardakis) Hologgitas of Newport for 57 years. Born at Newport Hospital on September 18, 1919, he was the son of the late Speros Hologgitas and Stella (Boukakeos) Hologgitas. Gus attended Rogers High School graduating in 1938 and shortly after was drafted into the US Army for WWII, serving until 1946. The majority of his assignment was at Ft. Sam Houston in TX. He was one of the founding members of the Church Endowment, formed in 1986. He held a position on the Board until just a few months ago. Gus was also an active member of the Newport Players Guild in the 1950's and 1960's starring in many productions, including "Plaza Suites" and "Midsummer Night's Dream". He was an avid reader of newspapers and books, which gave him plenty of trivia and odd facts. Gus was also a member of the Newport Histori-

cal Society, Preservation Society of Newport County, Newport Art Museum, tol. He enjoyed watching the Boston Red Sox and the New England Patriots.

Estelle Antonio, 77, of Simsbury, a pillar of the St. George community died on Friday, December 6. Mrs. Antonio was born and grew up in Newport, Rhode Island and was a graduate of Central Connecticut State University. She worked as a kindergarten teacher in East Hartford from 1958 to 1964, when she and her husband opened Antonio's Restaurant in Simsbury and a local landmark still in the family. She was deeply involved in church and Daughters of Penelope activities for decades, as well as in a host of civic and educational activities.
